SECTION I

BENCHMARKING OF BEST PRACTICES OF BAYAWAN CITY, NEGROS ORIENTAL AND SILAY CITY, NEGROS OCCIDENTAL FOR EMPLOYEES OF THE CITY GOVERNMENT OF BATAC

1. The **City Government of Batac**, through the GENERAL FUND (**OFFICE OF THE HUMAN RESOURCE MANAGEMENT OFFICE: OTHER PROGRAMS-BENCHMARKING**) intends to apply the sum of **TWO MILLION EIGHT HUNDRED THOUSAND & 00/100 PESOS (Php 2,800,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **BENCHMARKING OF BEST PRACTICES OF BAYAWAN CITY, NEGROS ORIENTAL AND SILAY CITY, NEGROS OCCIDENTAL FOR EMPLOYEES OF THE CITY GOVERNMENT OF BATAC**. Bids received in excess of the ABC shall be automatically rejected during bid opening.
2. The **City Government of Batac** now invites bids for the **BENCHMARKING OF BEST PRACTICES OF BAYAWAN CITY, NEGROS ORIENTAL AND SILAY CITY, NEGROS OCCIDENTAL FOR EMPLOYEES OF THE CITY GOVERNMENT OF BATAC**. Delivery of the Goods is required **30 Days upon receipt of Notice to Proceed**. Bidders should have completed, within **Five (5) Years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from **City Government of Batac** and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.
5. A complete set of Bidding Documents may be purchased by interested Bidders on **April 29, 2019** (from 8:00 AM to 5:00 PM) to **May 20, 2019** (from 8:00 AM to 12:00 PM) from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Five Thousand Pesos (Php 5,000.00)**.

6. The City Government will hold a Pre-bid Conference on **May 7, 2019** at 1:00 in the afternoon at the City Government of Batac, BAC Office 3rd Floor City Hall Building .
7. Bids must be duly received by the BAC Secretariat at the address below on or before **May 20, 2019 at 12:00 NN**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the **ITB Clause 18**.

Bid opening shall be on **May 20, 2019, 1:00 PM** at BAC Office 3rd Floor City Hall Building Bids will be opened in the presence of the Bidders' representatives (With Authorization) who choose to attend at the address below. Late bids shall not be accepted.
8. All Bids to be submitted shall be in accordance with RA 9184 and it's Latest Revised IRR.
9. The **City Government of Batac** reserves the right to accept or reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award an in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
