The **CITY GOVERNMENT OF BATAC**, through the **GENERAL FUND(RA 7171 FY 2014)¹** intends to apply the sum of **FORTY NINE MILLION THREE HUNDRED ELEVEN THOUSAND FIVE HUNDRED SIXTY & 70/100 (Php 49,311,560.70)** being the Approved Budget for the Contract (ABC) (with breakdown per item below) to payments under the contract for the following:

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from **CITY GOVERNMENT OF BATAC** and inspect the Bidding Documents at the address given below from **May 20, 2019 (from 8:00AM TO 5:00PM) up to June 10, 2019 AT 8:00AM-12:00 NOON**

4. A complete set of Bidding Documents may be acquired by interested bidders on May 20, 2019 **(from 8:00AM to 5:00PM) up to June 10, 2019 AT (8:00AM-12:00 NOON)** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount indicated in the table above.
5. The City Government will hold a Pre-bid Conference on **May 29, 2019 at 1:00 PM** in the afternoon at the City Government of Batac, BAC Office 3rd Floor City Hall Building.
6. Bids must be duly received by the BAC Secretariat at the address below on or before **June 10, 2019 AT 12:00 NN**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **June 10, 2019, 1:00 PM** at BAC Office 3rd Floor City Hall Building. Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.
7. Only the Authorized Representative of the Bidders shall be entertained in all the stages of procurement.
8. The **CITY GOVERNMENT OF BATAC** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
