**RESOLUTION RECOMMENDING THE AWARD OF BID TO  
 ERGA BUILDERS MULTIVENTURES INC.**

AS A CONSEQUENCE OF RESORT TO "NEGOTIATED PROCUREMENT-SMALL VALUE  
**PROCUREMENT**"  
 AS AN ALTERNATIVE METHOD OF PROCUREMENT

WHEREAS, Republic Act No. 9184 provides for the modernization, standardization and regulation of the procurement activities of the Government.

WHEREAS, with the prior approval of the CITY MAYOR, as the head of the procuring entity, the CITY GOVERNMENT OF BATAC may, whenever justified by the conditions provided for in R.A. No. 9184, resort to any of the alternative methods of procurement provided for in the Implementing Rules and Regulations of R.A. No. 9184 (IRR).

WHEREAS, the CITY MAYOR has approved "NEGOTIATED PROCUREMENT-SMALL VALUE PROCUREMENT", as the particular alternative method for the PURCHASE OF AIRCOOLERS, subject of this Resolution, as per recommendation of the BIDS AND AWARDS COMMITTEE.

WHEREAS, the conditions and/or requirements for "NEGOTIATED PROCUREMENT SMALL VALUE PROCUREMENT" under Section 53.9 of the IRR has been met and/or complied with for the subject procurement.

WHEREAS, the BIDS AND AWARDS COMMITTEE, through its Secretariat, had negotiated with and received filled-up Request for Quotation Forms from the following bona fide suppliers of known qualifications, to wit:

- (a) **ERGA BUILDERS MULTIVENTURES INC.**
- (b) ECD ENTERPRISES
- (c) JOSHUA AND CALEB GENERAL MERCHANDISE

for the PURCHASE OF AIRCOOLERS in the amount of THREE HUNDRED EIGHTY THOUSAND SEVEN HUNDRED NINETY EIGHT & 00/100 PESOS (Php 380,798.00).

WHEREAS, after a careful evaluation of quotations submitted by the aforesaid suppliers, the BIDS AND AWARDS COMMITTEE found out that ERGA BUILDERS MULTIVENTURES INC. had submitted quotations on time, quoted the lowest and the most advantageous prices to the CITY GOVERNMENT OF BATAC.
