A. QUALIFICATIONS OF BIDDERS

The Public Auction is open to All Business Entrepreneurs who shall comply with the following Eligibility Requirements:

- 1. Latest Business Permit
- 2. DTI/SEC
- 3. Latest Income Tax Return, stamped "Received" by BIR or its duly accredited and authorized institutions

B. SUBMISSION OF BIDS

Submit your proposal printed in the Bid Proposal Form with your name, signature, business name, address, and contact number together with your eligibility documents. Submit the duly accomplished bid proposal form on or before April 2, 2025 at 3:30 P.M. at the City General Services Office. A bid submitted cannot be changed or withdrawn after the deadline of submission of bid. Late bids shall not be accepted.

A complete set of the Bid Proposal Form and Instruction to Bidders (ITB) may be acquired by interested bidder from March 26, 2025 8:00 A.M. to 5:00 P.M. to April 2, 2025 8:00 A.M. to 3:30 P.M. at the City General Services Office, Washington Street, City of Batac, Ilocos Norte or email us at gso.batac@gmail.com. Viewing of items for sale is open at the same date and time.

C. BID BOND

The envelope should also include documents applicable as stated above together with the corresponding bid bond equivalent to 10% of the total bid amount, in a **sealed envelope** indicating your Name, Address and Contact Numbers.

The bidder's bond will be returned to the non-winning proposal right after the auction. On the other hand the bid bond of the winning bidder shall form part of the purchase price. However, the ten percent (10%) bid bond shall be forfeited if the full price is not paid by the winning within the prescribed period stated in the Notice of Award. Upon payment of the full price, the winning bidder shall be the recipient of the unserviceable properties and is required to haul the same within **ten (10) working days.**

D. OPENING OF BIDS

Bids submitted shall be opened and tabulated in the presence of the auctioneers on **April 2, 2025** at City General Services Office, Washington Street, City of Batac, Ilocos Norte. An Abstract of Bids shall be prepared by the City Disposal Committee.

Unsigned proposal, proposal lower than the floor price and those without the corresponding bid bond shall automatically be disqualified.

In case of a "Tie" among bidders which takes place when two or more bidders offered exactly the same price quotation, all concerned bidders of their dully authorized representative shall appear after the conduct of the bidding and witness the drawing of lots. This shall be the basis to determine the winning bidders based on sheer luck or chance corollary to the Government Procurement Policy Board (GPPB) Circular No. 06-2005 dated 05 August 2005. The "drawing of lots" shall be conducted by the Disposal Committee in the presence of the concerned bidders.

This Invitation to Bid will be posted in conspicuous places within the City Government of Batac's vicinity. The City Government of Batac – City Disposal Committee reserves the right to reject any or all bids, or any part thereof, waives any formality, requirements or defects contained therein and will accept the offer it considers most advantageous to the government.
